Greece and Macolin Convention

Macolin Convention (Council of Europe)

 The only international, legally-binding instrument that can secure and sustain effective global co-operation against the manipulation of sports

Greece:

- signed on 2014
- ratified on 2019 (Law 4639/2019)
 - (NOR, POR, UKR, MOL, ITA, SWI, GRE)

The National Platform for Sport Integrity (acronym in Greek: EPATHLA = awards) derives from Article 13 of the Council of Europe Convention on the Manipulation of Sports Competitions (Macolin Convention) and it is the main tool for its implementation in our country.
